### The role

You will work at the intersection of instructional design, Al-powered tools (particularly generative AI) and innovation delivery, collaborating with colleagues across the School to develop and deploy solutions that are future-focused, scalable and evidence-based.

This role is ideal for someone with deep expertise in learning design, a passion for technologyenabled learning and the ability to navigate ambiguity and thrive in a fast-paced, evolving environment.

# Responsibilities

#### Learning design-led technology innovation

- Drive the design of high-quality, innovative learning experiences for both B2B and B2C programmes, grounded in evidence-based pedagogical practice for adult learning.
- Collaborate with the Learning Innovation & Impact team to build and refine custom GPTs, AI-enabled tools and prompt libraries to enhance solution and programme design.
- Ensure that technology-enabled learning designs respect and amplify instructional design principles, rather than replacing them.
- Support the development of frameworks, tools and templates to embed learning

innovation and impact approaches across the programme lifecycle.

# Agility, innovation and problem-solving in ambiguous environments

- Thrive in rapidly changing environments by adapting approaches, refining tools and identifying quick wins without losing sight of long-term strategy.
- Use iterative, design-thinking approaches to test, learn and scale solutions in collaboration with faculty and internal teams.
- Bring a practical, solutions-oriented mindset to complex challenges, applying both creativity and rigour to design problems.
- Champion a fail-forward, learn-fast culture that values experimentation and continuous learning.

#### Technology-enabled learning innovation

- Act as a key contributor to the team's Al innovation agenda, working on the implementation of generative Al tools that reduce manual design load while improving design quality.
- Develop structured guidance and learning templates that can be translated into Al-ready formats, feeding into prompt libraries and learning co-pilots.
- Work with content owners to shape high-value curricular design assets that fuel Al-enabled tools.
- Help test and evaluate generative Al pilots, refining functionality, prompting and structure in real time with user feedback.

• Collaborate on the design and implementation of impact evaluation processes that integrate seamlessly into the learning experience.



- Work with AI tools and analytics to derive insights from feedback and outcomes data to continuously improve programme design.
- Align learning and impact evaluation efforts with rankings performance goals and client impact priorities.

- Partner with Programme and Academic Directors, client teams and faculty to co-create learning solutions.
- Contribute to community engagement and consultation activities to embed feedback into design practice.

- A bachelor's degree in a relevant field.
- Proven expertise in instructional design or learning design, with a strong portfolio of applied work.
- Experience with generative AI tools or demonstrable interest in applying emerging technologies to education.
- Ability to work independently in fast-paced, ambiguous environments, balancing multiple priorities with agility and focus.
- Excellent problem-solving, collaboration and communication skills.
- Strong project management capabilities, including planning, coordination and delivery across cross-functional teams.
- Familiarity with learning technologies and platforms.
- Comfort with data analysis and impact evaluation frameworks.
- A proactive, learning-oriented mindset, with a passion for innovation, experimentation and continuous improvement.

#### Desirable selection criteria

- Postgraduate qualification in instructional design, learning science or related field.
- Experience working in executive education or professional learning environments.
- Familiarity with AI prompt engineering or learning design-to-AI translation work.
- Project management qualification (e.g., PRINCE2, Agile, PMP).

#### The University's policy on retirement

The University operates an Employer Justified Retirement Age (EJRA) for very senior research posts at grade RSIV/D35 and clinical equivalents E62 and E82 of 30 September before the 70th birthday. The justification for this is explained at https://hr.admin.ox.ac.uk/the-ejra.

For **existing** employees, any employment beyond the retirement age is subject to approval through the procedures <u>https://hr.admin.ox.ac.uk/the-ejra</u>.

There is no normal or fixed age at which staff in posts at other grades have to retire. Staff at these grades may elect to retire in accordance with the rules of the applicable pension scheme, as may be amended from time to time.

#### Equality of opportunity

Entry into employment with the University and progression within employment will be determined only by personal merit and the application of criteria which are related to the duties of each particular post and the relevant salary structure. In all cases, ability to perform the job will be the primary consideration. #### Annual leave

38 days (inc. public holidays). Long service additional annual leave – up to 5 days per annum, pro rata for part time employees. Previous service within higher education sector can be recognised. An additional scheme enables staff to request to purchase up to 10 additional days in each holiday year.

#### Salary and salary sacrifice schemes

#### Pension

If you are on an academic or academic related pay scale (grade 6 or above), you are automatically a member of USS. Employer contribution is 14.5% and Employee contribution is 6.1%.

If you are on a pay scale other than academic or academic related (grade 1-5) you are automatically a member of OSPS. Employee contribution can be between 4%-8% and Employer contribution 6%-10%.

#### University discounts

All University staff can purchase a NUS Extra discount card for £12 for 12 months (£22 for 2 years, £32 for 3 years) which gives access to numerous exclusive offers and discounts from many popular retailers. There are a wide range of other discounts from external companies available using a university card.

#### University Club

Membership of the University Club is free for all University staff. The University Club offers social, sporting and hospitality facilities.
